

# Spiritual Research Network Urgent Need

## *Immediate Family and SRN Office Relocation*

### *Financial Assistance Needed*

#### **IMMEDIATE MOVE BEGINS IN 1 to 5 DAYS**

I am writing to communicate to you several very important things, the first of which is immediately affecting our family, our SRN office and our 1,000 book research library.

As of late yesterday afternoon, I was informed that the house we have been renting since our return from Scotland is to immediately go on the market for sale. After discussion with our property manager, and the fact that we lack personal funding for two rents (for a weeks moving time), it behooves us to make an immediate move to another rental home here in Cambria - within roughly 1-5 days. To say the least, this is a huge project, comes at a most inconvenient time, and includes a number of large expenses.

#### **DONORS CAN HELP WITH A STUDIO / OFFICE SPACE FOR SRN**

Over the past months our office space has been our bedroom and half of our garage. Last night we were offered an incredible local office/studio space for \$400.00 dollars a month, about half the going price. This space would be ideal for an SRN office, recording/video studio, library storage, etc. However, in order to make this happen we need more monthly donors.

#### **MISSIONS/MINISTRY SUPPORT vs. LAWSON FAMILY WORKING FOUR JOBS**

I think most of you know that I am currently not salaried at all through *Spiritual Research Network, Inc.* We were anticipating having at least a little missions support through SRN but this has not happened yet.

Since we have returned from being overseas, Jenn and I have both had to go back to work full-time and then some. Between the two of us we are working four jobs. We have started our own businesses and we both work for other employers in order to make ends meet financially. I have gone from being a full time salaried missionary / pastor (11 years) to now personally working outside of ministry activities to sustain and provide for my family.

#### **LETTER OF EXEMPTION RECEIVED FROM FRANCHISE TAX BOARD**

Over the last year, SRN's financial board has gone through the motions in order to make SRN a nonprofit. Our purpose in doing this was and is to set an example of accountability as well as benefit our donors. We did recently receive our *Letter of Exemption* from the *California Franchise Tax*
